Form 990, Part VI, Section A, Line 4 - On May 27, 2022, Wheel Fun filed amended articles of incorporation with the AZ Corporation Commission (ACC) shortening its name to Wheel Fun and removing all geographical restrictions from its mission in its governance. The ACC approved FUN's amended articles on July 8, 2022. At its May 2022 board meeting, Wheel Fun directors approved the above action and modified its bylaws to remove all geographic restrictions and to increase the number of Directors to nine.
